**ORDER**

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993, Murshidabad Rayra Education Society, Flat No-210, 5/83, Kandi Sagar Main Road, VII/Town/City-Rasorah, P.O. Rasorah, Tehsil/Taluka/Town/City-Kandi, Dist.-Murshidabad, West Bengal-742137 has applied for grant of permission for Kandi Primary Teachers Training Institute, Flat No.210, VII-Rasorah, P.O. Rasorah, Tehsil/Taluka/Town/City-Kandi, Dist.-Murshidabad, West Bengal-742137 for Addl. Intake of D.B.Ed. course online on 28/12/2012 for 2 year duration under Section 15(1)(a) of the NCTE Act, 1993 and hard copy received by Eastern Regional Committee of on 04/01/2013.

2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VI and Videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements, under the provisions of NCTE ACT, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resource etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants permission to Kandi Primary Teachers Training Institute, Flat No.210, VII-Rasorah, P.O. Rasorah, Tehsil/Taluka/Town/City-Kandi, Dist.-Murshidabad, West Bengal-742137 for conducting D.B.Ed. programme of two year duration with an A-03 intake of 50 students (Addl. One Inty) (existing 50 intake + additional 50 intake) , thus making the total intake of 100 (One hundred) from the academic session 2015-2016, under clause 7(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:

- (i) The Endowment fund of 5 lakhs and Reserve fund of 7 lakhs kept in joint account with Regional Director of NCTE should be maintained Regularly, Loan raising against or mortgaging of FDR shall not be done.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
